**Participant Release, Waiver and Consent**

**1. Acknowledgement and Assumption of Risk & Consent to Participate:**

I/Participant may take part in activities that involve inherent dangers and hazards that may put me/Participant at risk or serious injury or illness, including death, property damage and financial or other loss. While the Regina 2014 North American Indigenous Games Host Society strive to reduce these risks, they can never be completely eliminated. I am/we are aware of and freely accept and fully assume the inherent risks associated with participating in the games, included but not limited to those described above. I/we also understand that the Regina 2014 North American Indigenous Games Host society will not be liable for any resulting injury or loss, regardless of the cause or activity.

**2. Request and Consent for Medical Care:**

In the event of injury or illness, the undersigned hereby request and consent to any and all medical examination, evaluation, and treatment, as may be necessary for the immediate welfare of the above-named Participant. I/Participant understand that health care providers will attempt to discuss treatment with the Participant's parent/guardian, but, if we cannot be contacted, we consent to and request that immediate emergency medical treatment be provided to the Participant.

**3. Intellectual property waiver:**

I/participant agree that any photograph, work expressed by any process analogous to photography, video or cinematographic film produced by, at the request or under the direction or control of the Regina 2014 North American Indigenous Games Host Society or under its supervision during the Regina 2014 North American Indigenous Games and in which I, or the minor person, appears may be used, reused, adapted, altered, cropped, produced, reproduced, published, republished, distributed to the public, communicated to the public by telecommunication, publicly presented as a cinematographic work, presented at a public exhibition, preserved, conserved or archived by the NAIG Council, the Regina 2014 North American Indigenous Games Host Society or the Province of Saskatchewan, their representatives, assigns, employees and agents and any person acting under their authority, for any purpose related to departmental programming and its promotion throughout the world and indefinitely including but not limited to, any publication, broadcast posting on the Internet (Web) advertising or display.

**5. Governing Law**

I/participant hereby agree that the resolution of any and all disputes arising from or in connection with my relationship with the NAIG Host Society, including any disputes arising under or in connection with this Agreement, shall be governed by and construed in accordance with the laws of the Province of Saskatchewan and the laws of Canada applicable therein. I/participant hereby acknowledge that the medical or other health care and treatment I/participant receive from the NAIG Host Society(as well as its agents, delegates, employees and any physicians and other independent health care practitioners) will be provided in the Province of Saskatchewan, and that the Courts of the Province of Saskatchewan shall have exclusive jurisdiction to hear any complaint, demand, claim, proceeding or cause of action, whatsoever arising from or in connection with that medical or other health care and treatment, or from any other aspect of this relationship

**6. Release of Liability, Waiver of Claims & Indemnity**
