

## **NAIG WEBSITE PRIVACY POLICY**

### **1. What information do we collect?**

You provide information when you register on our site, place an order, or communicate with us by phone, e-mail, or otherwise. As a result of those actions, you might supply us with such information as your name, address, phone numbers, email address, credit card information, and mailing address.

### **2. What do we use the information for?**

We use the information that you provide for such purposes as:

- To personalize your online shopping experience
- To improve our website and stores
- To improve customer service
- To respond to your requests
- To communicate with you; or
- To process or verify a transaction

### **3. How do we protect your information?**

We implement a variety of security measures to maintain the safety of your personal information when you place an order, submit, or access your personal information.

We offer the use of a secure server. All supplied sensitive information is transmitted via GEO TRUST, Rapid SSL Certificate. The Secure Sockets Layer (SSL) software is the industry standard and among the best software available today for secure online commerce transactions. It encrypts all of your personal information, including credit card number, name, and address, so it cannot be read as it travels over the Internet. It is only accessible by those authorized with special access rights to such systems, and are required to keep the information confidential.

### **4. Do we use Cookies?**

Cookies are unique identifiers that we transfer to your device to enable our system to recognize your device and to provide certain features, such as helping us remember and process the items in your shopping cart and saving your preferences for future visits. They enable our

service provider's systems to recognize our browser and capture and remember certain information.

#### **5. Do we disclose any information to outside parties?**

We employ other companies and individuals to perform functions on our behalf. Examples include fulfilling orders, delivering packages, sending postal mail and e-mail, removing repetitive information from customer lists, analyzing data, providing marketing assistance, processing credit card payments, and providing customer service. They have access to personal information needed to perform their functions, but may not use it for other purposes.

Your information, whether public or private, will not be sold, exchanged, transferred, or given to any other company for any reason whatsoever, without your consent, other than for the express purpose of delivering the product.

We may also release your information when we believe release is appropriate to comply with the law, enforce our site policies, or protect ours or others rights, property, or safety.

#### **6. Third party links**

Occasionally, at our discretion, we may include or offer third party products or services on our website. These third party sites are separate and have independent policies. We have no responsibility or liability for the content and activities of these linked sites. Nonetheless, we seek to protect the integrity of our site and welcome any feedback about these sites.

#### **7. Application of Online Privacy Policy**

This online privacy policy applies only to information collected through our website and not to information collected online.

#### **8. Policy Changes:**

We may, from time to time, decide to change our privacy policy in whole or in part. In this case, we will inform you by posting a notice on our web site. Those changes will go into effect on the date posted in the notice. The new policy will apply to all current and past users of our website.

#### **9. What Choices Do I have?**

You can always choose not to provide information, even though it might be needed to make a purchase or to take advantage of some website features. For example, because cookies allow you to take advantage of some of NAIG's essential features, if you block or otherwise reject our cookies, you will not be able to add items to your Shopping Cart, proceed to Checkout, or use any NAIG services that require you to register.

The "Help" feature on most browsers will tell you how to prevent your browser from accepting new cookies, how to have the browser notify you when you receive a new cookie, or how to

disable cookies altogether. Additionally, you can disable or delete similar data used by browser add-ons.
